JOSE ROSAS AISPURO TORRES, GOBERNADOR CONSTITUCIONAL DEL ESTADO LIBRE Y SOBERANO DE DURANGO, CON FUNDAMENTO EN LO DISPUESTO POR LOS Artículos 40 segundo párrafo fracciones I y IV, 50, 98 fracción XXVI y 150 fracción II de la Constitución Política Local; 1, 9 y 16 de la Ley Orgánica de la Administración Pública del Estado, he tenido a bien emitir el siguiente **ACUERDO ADMINISTRATIVO** en virtud del cual se dan a conocer LOS IMPORTES ENTREGADOS A LOS MUNICIPIOS DEL ESTADO DE DURANGO POR CONCEPTO DE **PARTICIPACIONES FEDERALES CORRESPONDIENTES AL CUARTO TRIMESTRE DEL EJERCICIO FISCAL 2019** con base en los siguientes:

CONSIDERANDOS

Que el artículo 6° de la Ley de Coordinación Fiscal establece que los Estados deberán publicar trimestralmente en el Periódico Oficial, así como en su página oficial de internet del Gobierno de la Entidad, el importe de las participaciones entregadas a sus municipios y, en su caso, el ajuste realizado al término de cada ejercicio fiscal, las cuales se deberán realizar conforme a los lineamientos que al efecto emita la Secretaría de Hacienda y Crédito Público.

Que los Lineamientos para la publicación de la información a que se refiere el artículo 6° de la Ley de Coordinación Fiscal, publicado en el Diario Oficial de la Federación de fecha 14 de febrero de 2014, señala que las Entidades Federativas deberán publicar de manera trimestral, mediante acuerdo en el órgano de difusión oficial del Gobierno de la Entidad Federativa, así como a través de su página oficial de internet, a más tardar el día 15 del mes siguiente a aquel en que se termine el trimestre que corresponda, incluyendo los montos de cada uno de los conceptos de las participaciones federales que se entregaron a cada municipio. Dicha información deberá presentarse acumulada al trimestre que corresponda, con el desglose mensual respectivo del trimestre de que se trate.

En virtud de lo anterior se expide el siguiente:

ÚNICO.- El presente Acuerdo tiene por objeto dar a conocer los montos entregados a los Municipios por concepto de Participaciones Federales correspondientes al 4° Trimestre del Ejercicio Fiscal de 2019

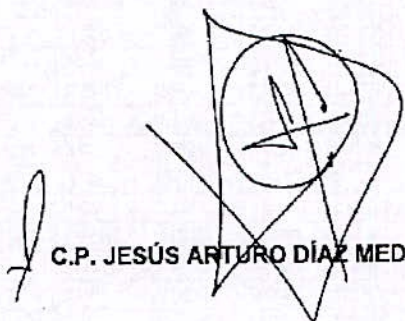
